## A Message from the Rector: The Ninth Commandment


**277** the Ninth Commandment, God's people are commanded not to willfully communicate a falsehood about anyone to misrepresent them (*Exodus 20:16*, KJV; see also *Deuteronomy 5:20* and Question 340, *To Be a Christian*). In ancient Israel, two or

three witnesses were required for any charge of a transgression of the law made against another person to stand (*Numbers* 35:30: **Deu-**

*teronomy* 17:6; *St. Matthew* 18:16).

If even two witnesses bore false testimony against a person accused of a capital crime, the accused would then be wrongfully executed. So serious a crime was lying against a person that anyone found to be a false witness in a legal case was to receive the same punishment he sought to inflict by bringing a false accusation or bearing false testimony (*Deuteronomy 19:16-19*).

The chilling effects of lying witnesses are shown in Queen Jezebel's plot to kill Naboth so that her husband King Ahab could take possession of his vineyard. The story is told in *I Kings 21:1-16* of how Jezebel wrote letters



in Ahab's name instructing the elders of Jezreel to proclaim a fast, set Naboth on high among the people, and have two base men bear false witness against him by saying that Naboth had cursed God and the king. Then they were to carry Naboth out and stone him to death. Of course, Ahab bore responsibility for all of this in allowing his wife to arrange for all these evil things to be done in his name. We see that lying gave rise to murder on the pretense of a capital crime having been committed. But neither Ahab nor Jezebel went unpunished, as God's word to Ahab spoken by Elijah makes clear (*I Kings 21:17-26*).

> In the Gospel according to St. Matthew, we read that the chief priests and the Sanhedrin tried to find false testimony against Jesus Christ in order to put Him to death,

but they did not find it even though many false witnesses came forward (<u>St. Matthew</u> 26:59). After these failed attempts, two witnesses came forward alleging that Jesus had said He could destroy the temple of God and build it again in three days (**St. Matthew** 26:60-

## The Ninth Commandment

(Continued from page 1) 61). To this charge Jesus remained silent (St. Mat*thew* 26:63*a*). But when the high priest asked Him if He was the Christ, the Son of God, Jesus' truthful reply, although He emphasized that it was the high priest who made this admission by his question, led to the high priest accusing Him of blasphemy, a capital crime in Judaism. If Jesus Himself had denied He was the Christ, the Son of the living God, He would have been guilty of bearwith Satan, the father of lies." Speaking to the Jews who would not believe Him, the Lord Jesus Christ characterized them and the Devil in these words:

> Ye are of your father the devil, and the lusts of your father ye will do. He was a murderer from the beginning, and abode not in the truth, because there is no truth in him. When he

speaketh a lie, he speaketh of his own: for he is a liar, and the father of it. *St. John* 8:44, KJV

The Lord declares there is no truth in the Devil, and this is why the Devil does not abide in truth.

The Devil tells lies, because he is the father of lies. By contrast, the Lord Jesus Christ is the way, the truth, and the life (*St. John 14:6*). Therefore, bearing false witness, or lying, aligns us with the Devil whereas speaking the truth aligns us with the Lord Jesus Christ and confirms we are God's children.

Another reason for refraining from lying and instead speaking the truth is that as Christians we all belong to the Lord Jesus Christ, and, being His Body, we are members of one another. St. Paul emphasizes this truth in his *Epistle to the Ephesians*:

> Wherefore putting away lying, speak every man truth with his neighbour: for we are members one of another. **Ephesians** 4:25, KJV

Apart from the miscarriage of justice that can result from false testimony in court, there is the extensive harm that can be done through slander and gossip, by which people spread falsehoods about others and so ruin their reputations. Great harm can be done by this. To Cretans who were prone to lving (St. Titus 1:12), St. Paul gave the command not to speak evil of anyone (St. Titus 3:2a). This is the principle Christians ought to follow in obeying the Ninth Commandment. When we ruin someone's reputation through slander and gossip, it is akin to killing that person. The circle of friends he had might no longer want to be his friends, or his chances of obtaining a good position may be lost, or his success in life somehow thwarted.

Dishonoring Christians who are poor by discriminating against them is also covered by this commandment, since we are creating the false (Continues on page 3)



ing false witness. It was in fact His accusers who were bearing false witness by accusing Him of blasphemy, since they falsely assumed He was only a man and not the Christ, the Son of God.

Why does God forbid His people from bearing false witness? According to our Catechism (Question 341, page 108, *To Be a Christian*), lying "defames and wounds my neighbor, erodes my love of truth, disobeys my Lord Jesus, and aligns me



*(Continued from page 2)* impressions that God does not honor them and that rich Christians are more acceptable to God than poor ones. If we live the truth and speak it, we align ourselves with the values and standards of God's kingdom and so show no partiality to the wealthy.

Even in the Church and in the teaching of ministers of the Gospel, false teachers can arise distorting the word of God and teaching false doctrines for the sake of making money. St. Peter warns us of this in *II St. Peter 2:1-3.* St. Paul anathematizes everyone who preaches a different Gospel to the Galatians than he preached to them (Galatians 1:6-9). St. John declares that many anti-christs have gone out into the world denying that Jesus is the Christ (St. John 2:18-29), effectively denying the Father and the Son. The anointing of the Holy Spirit, St. John explains, teaches Christians the truth and helps them to discern false teachers and false teaching.

In keeping the Ninth Commandment, our aim in life should always be to speak the truth in love and avoid saying anything false about anyone else, or even about ourselves. St. John reminds us that if we say we have no sin, we deceive ourselves, and the truth is not in us (*I St. John* 1:9), since we are claiming that God's judgement that all mankind has sinned and does sin is false (I St. John 1:10: Romans 3:9-20). To counter this, we must always believe and maintain the truth that God speaks concerning us and realize that we are sinners saved by grace and committed to determinedly following Christ the Way.

## Communication in a Disaster: How Can I Tell My Family I'm OK?

**So** far I have covered Plain Old Telephone Service (POTS), cellular phones, and Internet communications. None of those methods is foolproof. In fact, all are likely to fail to some degree or at some point after a disaster. So, how do you maximize your chances of getting that message out?

Have a plan in place before it is needed. For all of the modes of connecting you need to know the phone number, text vou choose should be far enough away that they are not going to be affected by the disaster in your area. They also should know your plan. It is best to have a single point of contact who will then be the clearing house for your entire family's information. That way you only have to contact one person who will then call the rest of your family, so you can deal with the emergency here. The whole family should know your contact person is the one to call to find out what is happening. Everyone

social media site that everyone can use to post information. Have several communication options, but prioritize the list for what works best for your family.

When a disaster strikes, your first priority is to ensure your own safety and that of your immediate family. Once that safety is established you can try reaching out to let the rest of your family know your status. To do that, you will need working equipment. Here are some recommendations for each of the com-

number, or e-mail address of the person you wish to notify. This information needs to be somewhere you can get to it even if power is off, you can't get into your house, or you are away from home. Having the info on you cell phone is good, but what if you lose your cell phone or the battery is dead? A paper copy in your wallet doesn't take up much space and is likely to stay with you wherever you are.

The contact person

should know the emergency contact plan. It is best to pick a family member who is located fairly far away but within the continental US, is reasonably tech savvy, and is known by everyone in your contact group.

Your cell phone and paper list should include as many ways as possible to reach your contact person: POTS phone number, cell phone number, work phone number, home email address, and work email address. You might also have a designated munications methods I've discussed:

**POTS:** Have a telephone that will work without grid power. AT&T still sells phones like the trimline corded phone for about \$15.

> Be prepared to try calling several times to get through. Even if there is no dial-

*(Continued from page 6)* tone, try periodically to see if the connection has been restored.

- Cell Phone: Have alternate ways to power your cell phone. At a minimum keep a 12volt charger and cable in your car. A battery bank is also good to keep handy. Some agencies recommend storing a cheap backup cell phone in your emergency kit so you have coverage if something happens to your primary phone.
- Internet: To connect to the Internet, your equipment will require AC power. Since power is likely to go off and be off for a while following an earthquake or other disaster, you will need an alternate source of power. An Uninterruptible Power Supply (UPS) can provide power for a limited time. A gen-

erator can provide power for a longer time, but requires regular maintenance and knowledge of how to safely use it. Also, a typical AT&T fiber connection needs power to the Optical Network Terminal (ONT), the router, and any switches between any wired equipment you intend to use and the router. Newer systems have the ONT and router plus Wi-Fi all in one. The device you are using to connect (cell phone, tablet, laptop, and so forth) will also need power or intermittent charging.

There are more exotic (and expensive) ways to make contact after a disaster. These will be the subject of our next installment.

#### \* \* \*

If you wish to learn more about disaster preparedness, consider joining your local Community Emergency Response Team (CERT). CERT educates volunteers about disaster preparedness for the hazards that may occur where they live. CERT trains volunteers in basic disaster response skills, such as:

- Fire safety
- Light search and rescue
- Team organization
- Disaster medical operations

The CERT program offers a consistent, nationwide approach to volunteer training and organization that professional responders can rely on during disaster situations, allowing them to focus on more complex tasks. Visit



## When We are Called to the Lord's Table

ur Lord is a God of order, so it is meet and right for us to conduct ourselves in a respectful and orderly fashion in His house. Because our Chapel is a former one-room schoolhouse and our Aisle is narrow, we have limited space to maneu-



ver. Following this process when we are called to the Lord's Table for Holy Communion keeps us from congesting the Aisle and Chancel:

> 1. Starting from the first pew in front, communicants

sitting on the Epistle side of the Chapel should go to the Altar Rail first. At the first step to the Altar Rail, each person will break off and go left or right toward the flags. This will allow the Altar Rail to be filled from the outside in, towards the center, so that everyone can avoid tripping and stepping over the legs and feet of those who are kneeling. It will also allow those in the pews to better gauge how many people can fit at the Altar Rail at one time

2. Once the Altar Rail is full, the process of coming to the rail pauses. Those who have not yet communed remain in the pews until the blessing for the previous group of communicants is given and they have returned to their

seats. This will avoid crowding in the aisle and ensure a safe return for everyone into the pews.

- 3. After the first group has communed and the blessing is given to depart, they will leave the Altar in the same order as they came forward.
- 4. Once the Aisle is clear of traffic, the next group of congregants may come forward. Communicants awaiting their turn at the Lord's Table should wait in their pews, not in the Aisle.
- 5. Father Parrish and Deacon Vogel will happily bring Holy Communion to those who cannot physically come to the Altar Rail.

Thank you for helping to keep (human) commotion out of Communion!


The Vestry will select a new project at its next meeting.


